

Voucher Virtual Permit Terms and Conditions 20/05/2021 v1.0

Voucher virtual parking permits are valid for use in voucher bays where parking is signposted as voucher parking only.

Voucher bays are only located in Romford in the roads listed below:

- Crow Lane
- Davidson Way
- Marks Road
- Richmond Road
- Shaftesbury Road
- Victoria Road
- Wheatsheaf Road

A virtual voucher permit is valid for 1 calendar year from the date of purchase.

The price of a voucher permit is displayed on the MiPermit application page.

Terms and Conditions of Use

1. The vehicle against which a voucher virtual parking permit is applied for must not carry more than 12 passengers exclusive of the driver, exceed 2.3 metres in height and must fit wholly within a parking bay.
2. Voucher virtual parking permits are only valid for use in the bays signposted for voucher parking only.
3. If the applicant no longer owns the vehicle to which the voucher virtual permit has been issued, the registration must be updated to their new vehicle in the users MiPermit account or cancelled if they no longer own a vehicle.
4. If an appropriate voucher bay is unavailable voucher virtual parking permits do not permit parking in other spaces marked for residents, businesses, pay and display, car parks or where other parking restrictions are in force.
5. If the vehicle is parked incorrectly outside of the bay markings or causing an obstruction a Penalty Charge Notice may be issued.
6. The Council is not able to allocate specific parking places to individual virtual voucher permit holders. The issue of a virtual voucher permit does not guarantee that a space will always be available.
7. The Council reserves the right to refuse a virtual voucher permit if there is reason to believe the permit applied for is not intended for use as stipulated in the terms and conditions.
8. The Council may withdraw a virtual voucher permit without refund if the holder persistently obstructs access or egress from a property or parks in contravention.
9. It is an offence to give false or misleading information. Failure to abide by one or more of the terms and conditions herein may lead to prosecution and the virtual voucher permit will be withdrawn.
10. Havering Council has a duty to protect public funds and may use information the applicant provides to detect and prevent fraud. For this reason, the council may also share this information with other organisations dealing with public funds.

11. Havering Council wishes to prevent fraudulent applications. If you know of or suspect permit fraud, please call 01708 432617. All calls are treated in the strictest confidence
12. The Council reserves the right to cease this permit scheme at any given time, providing the applicant with one month's notice in writing. In the event of the permit scheme terminating the applicant will receive a refund at the pro-rata rate of the remaining unexpended time.
13. The virtual voucher permit is valid for one year. The applicant is solely responsible for renewing their virtual voucher parking permit before it expires.
14. If a virtual voucher permit is cancelled, the remaining period the virtual permit is valid for is refunded in unused whole calendar months to the credit/debit card used for purchase.
15. On occasions the Council may suspend the whole or part of a parking place. You must ensure your vehicle is not parked in a place where parking has been suspended, as you may be issued with a Penalty Charge Notice and your vehicle may be removed.
16. Virtual voucher permits must not be used by the virtual permit holder to carry out the sale of goods or services.
