#### **ENFORCEMENT NOTICE**

**ISSUED BY:** London Borough of Havering (herein after referred to as "the Council")

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to the Council that there has been a breach of planning control, under Section 171A(1)(a) of the above Act, at the land described below. They consider that it is expedient to issue this Notice, having regard to the provisions of the development plan and to other material planning considerations.

#### 2. THE LAND AFFECTED

The land known as **64 BERWICK ROAD, RAINHAM, RM13 9QL**, shown edged in black on the attached plan and is registered under Land Registry Title Number **EX51200**.

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission, alterations to the main roof including the construction of two dormer windows one on each flank roof elevation.

#### 4. REASONS FOR ISSUING THIS NOTICE

- (1) It appears to the Council that the above breach of planning control has occurred within the last four years and that steps should be taken to remedy the breach by Section 173 4(a) or to remedy any injury to amenity which has been caused by the breach.
- (2) The unauthorised side dormer windows, by reason of their excessive scale, depth and render finish, appear as an unacceptably dominant and visually intrusive feature in the street scene and rear garden environment harmful to the appearance of the surrounding area contrary to Policy 26 of the Havering Local Plan (2016-2031) and the Residential Extensions and Alterations Supplementary Planning Document.
- (3) The windows in the side dormer, by reason of their position and proximity to neighbouring properties, causes overlooking and loss of privacy which would have a serious and adverse effect on the living conditions of adjacent occupiers at No.62 Berwick Road, Rainham, contrary to Policies 7 and 26 of the Havering

Local Plan (2016-2031) and Residential Extensions and Alterations Supplementary Planning Document.

(4) The Council does not consider that planning permission should be granted because conditions attached to any consent would not overcome these problems and because planning permission has already been refused under application P2390.21.

#### 5. WHAT YOU ARE REQUIRED TO DO

1. Demolish the two dormer windows one on each flank roof elevation and make good the resulting openings in the roof to match the profile of the original roof line. All materials to match the original roof in colour, texture and size of tiles;

OR

 Demolish or amend the two dormer windows one on each flank roof elevation, so that the resulting roof design accords exactly with the approved plans, granted under planning permission reference P0984.13, attached as LBH 1 & LBH 2. All materials to match the original roof in colour, texture and size of tiles;

#### **AND**

4. Remove all building materials and debris from the site as a result of taking step 1 or 2 above.

#### 6. TIME FOR COMPLIANCE

**4 MONTHS** after the date when this Notice takes effect.

#### 7. WHEN THIS NOTICE TAKES EFFECT

#### THE RIGHT TO APPEAL

Those with a legal or equitable interest in the land or who is a relevant occupier can appeal against this Enforcement Notice to the Planning Inspectorate acting on behalf of the Secretary of State before 13<sup>th</sup> April 2022. Further details are given in the attached explanatory note.

#### WHAT HAPPENS IF AN APPEAL IS NOT RECEIVED

If an appeal is not received against this Enforcement Notice, it will take effect on 13<sup>th</sup> April 2022 and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period specified in the Notice.

FAILURE TO COMPLY WITH AN ENFORCEMENT NOTICE WHICH HAS TAKEN EFFECT CAN RESULT IN PROSECUTION AND/OR REMEDIAL ACTION BY THE COUNCIL.

#### **EXPLANATORY NOTES**

#### STATUTORY PROVISIONS

#### THE RIGHT TO APPEAL

Any appeal must be in writing and received, or posted (with the postage paid and properly addressed) in time to be received in the ordinary course of the post, by the Planning Inspectorate before 13<sup>th</sup> April 2022.

If an appeal against this Notice is intended, the instructions given on the information sheet from the Planning Inspectorate which accompanies this Notice should be followed.

#### **GROUNDS OF APPEAL**

The grounds of appeal are set out in Section 174 of the Town and Country Planning Act 1990 (as amended) you may appeal on one or more of the following grounds:

- (a) that, in respect of any breach of planning control which may be constituted by the matters stated in the Notice, planning permission ought to be granted, as the case may be, the condition or limitation concerned ought to be discharged;
- (b) that those matters have not occurred;
- (c) that those matters (if they occurred) do not constitute a breach of planning control;
- (d) that, at the date when the notice was issued, no enforcement action could be taken in respect of any breach of planning control which may be constituted by those matters;

- (e) that copies of the Enforcement Notice were not served as required by section 172;
- (f) that steps required by the notice to be taken, or the activities required by the notice to cease, exceed what is necessary to remedy any breach of planning control which may be constituted by those matters or, as the case may be, to remedy any injury to amenity which has been caused by any such breach;
- (g) that any period specified in the notice in accordance with section 173(9) falls short of what should reasonably be allowed.

Not all these grounds may be relevant to you.

#### PLANNING APPLICATION FEE

Should you wish to appeal on ground (a) - that planning permission should be granted for the unauthorised development or use, then a fee of £412 is payable to the Council when the appeal is lodged. If this fee is not paid, the planning merits of the appeal will not be considered by the Planning Inspector.


#### STATEMENT ON GROUNDS OF APPEAL

The grounds of appeal must be submitted to the Planning Inspectorate, either when giving notice of the appeal or within 14 days from the date on which the Planning Inspectorate sends you a notice so requiring, a statement in writing specifying the grounds on which the appeal against the Enforcement Notice is being made and stating briefly the facts on which you propose to rely, in support of each of those grounds.




