 - 3. On Monday 12th April 2021 at approximately 15:20, eight (8) caravans and none (9 vehicles entered the car park of Bretons Outdoor Recreation Centre, Rainham Road, Rainham Essex.
 - 4. This site is included within the interim High Court injunction.
 - 5. The police arrived on site at 15:27.

I am employed as a Tactical Enforcement Officer by the London Borough of Havering and I am duly authorised to make this statement.

I have been employed in a full time capacity by the council, as a Tactical Enforcement Officer since June 2020.

As a Tactical Enforcement Officer, I am responsible for dealing with Anti-Social Behaviour and enforcement issues within Havering Parks.

On Wednesday 8 June 2022, I and my colleague Tibor Bern were asked by our managers to attend Upminster Rugby Club, Hall Lane RM14 1AU as there were reports that there were travellers parked on the playing fields.

The playing fields are owned by Havering council and any persons and their vehicles who park in this way on council owned land is breaching a High Court injunction numbered QB-2019-002737 issued by the High Court of Justice on 11th September 2019.

We were asked to attend the Upminster Rugby Club to establish the facts and to meet with police officers who were also asked to attend.

We arrived at approximately 11.00 hours and found three caravans and two cars on the field, parked near to the rugby club pavilion, next to the car park.

There are two gates to this field, one had no padlock on the gate and one had a padlock that was locked but not securing the gate.

I produce a photograph that I took of the open gate without the padlock as Exhibit WL1

We also saw three adults, a number of children and two small dogs in the area.

As we arrived a third car was leaving the field and drove out into Hall Lane.

We waited for the police officers to arrive and as we did so, one of the vehicles was driven around the playing field, across the rugby pitches.

The police officers arrived and together with them, we carried out a welfare check on all those who had arrived in the caravans.

The police officers asked a female for her name as she was talking on behalf of the group, and she said that it was Linda McDonald and she gave her date of birth as 1st January 1984.

She was in a caravan, that was parked on the field next to a green Toyota Landcruiser index number GV55LWO.

I produce a photograph that I took of this vehicle as Exhibit WL2

The other vehicle was a white estate car bearing Irish number plates.

After the police officers completed their checks, we had a brief discussion with them and they contacted the council to ascertain if the injunction was still valid to be served.

They were told that it was valid and at 12.35 hours I served the injunction on the female who identified herself as Linda McDonald.

We explained that this document required them to leave the land, and if they failed to do so, they would be in breach of a High Court injunction.

After a short discussion they were advised that they should leave by 15.00 hours and they were advised that we would wait until they leave, along with police officers.

A number of other council officers and vehicles arrived from the Parks Department at approximately 13.30 hours to check to see if there had been any damage caused to council property.

At 14.439 hours, the three caravans and the vehicles towing them left the playing field.

I took two photographs of the vehicles and caravans as they left and I produce these as Exhibits WL3 and WL4


