

# Examination of the Havering Local Plan 2016-2031

## Timeline

### **2018 – March**

The Havering Local Plan (2016-31) and supporting documents were submitted to the Secretary of State for the Ministry of Housing, Communities and Local Government for independent examination on 27 March 2018.

### **2018 – October**

Examination of the Havering Local Plan took place between Tuesday October 9<sup>th</sup> 2018 and Thursday October 18<sup>th</sup> 2018.

### **2019 – May**

The reconvened examination took place on Wednesday 29<sup>th</sup> and Thursday 30<sup>th</sup> May

### **2020 – August**

The Council published Main Modifications for consultation. The Council proposed a number of additional 'minor' modifications (e.g. typographical errors, clarifications and factual updates) to improve the clarity of the Local Plan. The consultation took place from 17<sup>th</sup> August to Monday 12<sup>th</sup> October 2020

### **2021 – January**

Comments received from the Main Modification consultation were considered by the Council, responded to and published.

### **2021 – June**

Correspondence with the Inspector on the Local Plans conformity with the London Plan.

### **2021 - July**

A consultation on Further Main Modifications was carried out from 8<sup>th</sup> July until 26<sup>th</sup> August 2022. The comments received were considered by the Council, responded to and published.

### **2021 – October**

The Inspector sent through her report stating the Havering Local Plan is considered sound.

### **2021 – November**

The Council voted on Wednesday 17<sup>th</sup> November 2021 to adopt the new Local Plan as agreed by the Inspector in her report.
