Why we collect your data

We process data to monitor the progress and status of arrivals under the Scheme, so that we can initiate sponsor and accommodation checks, issue thank you payments to hosts and provide any local authority support to guests as is required.

The lawful basis for processing your data

How we collect and use your data

Your data will be shared by Ministry of Housing, Communities and Local Government HMCLG and the Home Office to the Council for the purpose of delivering our obligations under the Scheme. Data shared to be used to:

- Undertake suitability checks of sponsors
- Communicate outcomes of these checks with HMG for safeguarding purposes
- Verifying and making thank you payments
- Allow quality assurance of care claims for children in local authority care

Who we will share your data with

Data may be shared with

- HMCLG and the Home Office to flag any safeguarding concerns
- Disclosure and Barring Service (DBS) for suitability checks



How long we will keep your data

We will keep your data safe and secure for a period of 7 year(s) in line with our retention Schedule. After this time, it will be securely destroyed.

How we protect your data

We comply with all laws concerning the protection of personal information and have security measures in place to reduce the risk of theft, loss, destruction, misuse or inappropriate disclosure of information. Staff access to information is provided on a need-to-know basis and we have access controls in place to help with this.
